## Introduction

### What is a Certified Professional Photographer?

The Certified Professional Photographer credential was created in 1977 as a way to identify professional photographers who have demonstrated technical competence through a written exam and photographic evaluation. The CPP Program empowers photographers to be more knowledgeable, successful, and technically equipped professionals in the industry.

Certification can give you an edge in:

- **Advertising:** Competition is very often fierce among professional photographers and differentiating yourself from the masses is crucial. Becoming a CPP instantly distinguishes you as someone who is serious about the business of photography.
- **Pricing:** One significant challenge often faced by professional photographers is justifying prices. Clients don't always understand how or why your prices are set the way they are. However, being a CPP allows you to easily explain the value in choosing your services.
- **Confidence:** When prospective clients learn about the effort that goes into becoming a CPP and that you have to recertify every three years, they'll quickly understand how seriously you take continued education and training when compared to the competition.

## Steps to Becoming Certified

1. **Join Professional Photographers of America (PPA)** if you aren't already a member.
2. **Declare your candidacy.** To do this, simply fill out the candidacy form. In this step, you will also need to pay the \$200 application fee. Your candidacy will be valid for two years.

3. **Prepare for the exam.** There are many resources provided to help you prepare for your CPP exam. Take advantage by visiting the CPP Exam Resources section of our website. We suggest downloading the CPP Test Outline, so you know what the exam covers. Then you can test your knowledge with the CPP Keywords, browse the suggested reading material, review the CPP Flashcards and take a Sample CPP Exam. You can also sign up for a CPP Prep Class which will help boost your confidence on the big day!
4. **Take the exam.** Once you feel confident you are ready to take the exam, simply register for the online exam. The CPP Exam passing score is a 70% or above. Score notifications are sent via email approximately 1-2 weeks from testing date.
5. **Submit images for the Technical Image Evaluation.** Once you have passed the exam you are eligible to submit. Each Image Evaluation will demonstrate three images. Please use the Technical Image Evaluation Guide and Sample Images to set up your evaluation. Make sure to reference the Equipment List for required and suggested equipment. You can submit your images as many times as needed within your TWO (2) year candidacy period. Should you not pass the technical image evaluation within your candidacy period you can reapply for candidacy, with the reduced cost of \$100 and an additional year to do so.
6. **Celebrate.** Once you get your certification, give yourself a break and celebrate... You'll deserve it!







## CPP Exam Overview

You've declared your candidacy and have decided to become a Certified Professional Photographer. Now it's time to get ready to take your exam. Use the resources below to help you prep!

### Exam Sections:

#### **Camera, Lenses, and Attachments**

Items relating to this category will include digital cameras as well as the various lenses, menu settings, and attachments that might be utilized.

#### **Exposure and Meters**

Items measuring this set of specifications will include: (1) how to meter for the correct exposure; and (2) the relationship between shutter speed and f-stop.

#### **Lighting**

This portion of the examination will measure (1) how to best light the subject; (2) possible types of lighting (Studio, Ambient, Flash, Daylight); (3) lighting design; and (4) lighting equipment.

#### **Composition and Design**

Items relating to this area will focus on the following topics: (1) Subject placement within image area; (2) Special effects, including props; (3) location; (4) clothing; (5) posing; (6) color harmony/color wheel; and (7) coordination of background and subject.

#### **Digital Post Production**

Items measuring this specification will include: (1) color space; (2) file formats and resolution; (3) color management; (4) digital manipulation; and (5) storage. Basic knowledge of post-production software will be necessary.

#### **Image Capture and Output**

Items included in this section will measure of image capture and output options (paper, electronic, web, etc.).

- ☐ Submit your Technical Image Evaluation during any evaluation period – they take place five (5) times a year.
- ☐ Each image must satisfy all the criteria listed in the [Technical Image Evaluation Checklist](#) and ALL THREE images must pass for your evaluation to pass. If one or more of your images does not pass you will only need to resubmit the failed image(s) in another evaluation period.
- ☐ You will be notified via email when an evaluation period opens or you can log on to your [MyPPA](#) dashboard and navigate to the [myAchievements](#) tab; select "Certifications" to expand the selection where you can view the option to "Upload Evaluation".
  - You may upload your evaluation during any open evaluation period (please note: the upload evaluation button will only be visible during the two-week period the evaluation is open).
- ☐ Results will be sent approximately 3 weeks from the Technical Image Evaluation deadline.

## Technical Image Evaluation – Quick Guide

You've passed the CPP Exam and are now ready to submit your 3 images for the Technical Image Evaluation. Here's your quick guide for the evaluation process. For more resources visit [PPA.com](http://PPA.com).

### ① ORDER

Order your Technical Image Evaluation Kit from [BlickU](http://BlickU).

Item	Quantity
Canson Mi Teintes drawing papers: 19" x 25", gray, single sheet	3
Styrofoam blocks and shapes – ball	1
Crayola crayon – set of 8 crayons	1
Sharpie marker – black	1
Blick hardwood manikin – 12"	1

### ③ PHOTOGRAPH

Set up your materials and lights per evaluation guidelines and photograph your 3 images. Use your [Evaluation Checklist](#) and [other resources](#) for help!



### ② PREPARE

Select a lighting scenario. Choose one lighting setup to create the three assigned images. Read each lighting setup closely to meet image requirements.

#### Three Assigned Images:

Image 1 – Straight on

Image 2 – Minimum depth of field

Image 3 – Maximum depth of field

#### Lighting Scenarios (choose 1 option):

Option 1: Electronic flash

(speed lights, studio, location strobes)

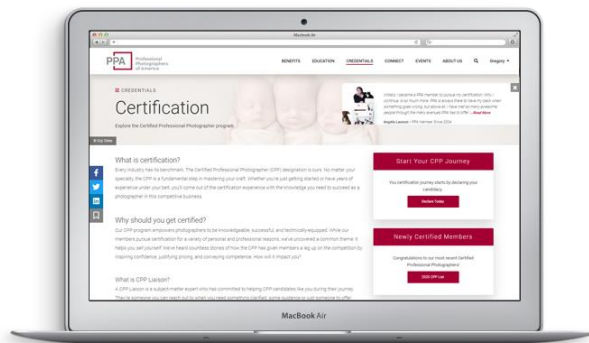
Option 2: Continuous light (modeling, tungsten, LED)

Option 3: Natural light (window, natural, available light)

### ④ SUBMIT

To submit images, log on to your [MyPPA](#) account and navigate to [myAchievements](#) and select [Certification](#), to upload your images during a scheduled Technical Evaluation period. All three images must pass to earn your CPP!

**Remember: Submit all images in RAW format.**





## Certification Technical Image Evaluation Checklist

You've created your images for evaluation and now it's time to check your work before uploading. Your submission must meet all of the following requirements in order to pass this portion of the evaluation and to acquire your certification. All of the images will be checked against the following criteria:

- ☐ **All approved kit items are used**
- ☐ **All images are submitted unedited in RAW format**
- ☐ **Layout/Composition:**
  1. Manikin is placed in the center of the composition with arms down at side standing straight, set of 8 crayons out of the box (black crayon required) are on the left-hand side of image, styrofoam ball on the right slightly in front of manikin, and black Sharpie (cap removed and placed on the end of the marker) in front of the Styrofoam Ball. This must match the example images.
  2. All items are within frame and no items are cropped from the image. All kit items are placed in the center of the composition.
  3. Gray paper acts as background.
- ☐ **Images fill the frame:** There should not be any floor space showing outside of the gray paper.
- ☐ **Camera Angle:** Angle of view and orientation of the set up should match the example image.
  1. Image 1 – Straight on, Portrait orientation
  2. Image 2 – Overhead, Landscape orientation
  3. Image 3 – Overhead, Landscape orientation
- ☐ **White Balance:**
  - For lighting scenario 1, 2 or 3 white balance is custom set.
- ☐ **Exposure:** Submitted files should be properly exposed with minimal clipping of shadows or highlights.
  - Acceptable highlight range: 220-250
  - Acceptable midtone range: 195-230
  - Acceptable shadow range: 5-35
- ☐ **Direction of Light:** The main light should be on camera left side of all images and each image should show proper light direction and dimension.
- ☐ **Sharpness:** Each image will be checked for correct sharpness.
  1. Image One: The set of items should be acceptably sharp with the background appearing softer as shown in the example images.
  2. Image Two: The top point of the manikin's head should be acceptably sharp, and the rest should fall off in sharpness.
  3. Image Three: The entire image should display acceptable sharpness all the way through.
- ☐ **Metadata:** All submitted files will be checked for the following in the metadata.
  1. Camera settings match the written instructions for f/stop
  2. The lens focal length should be between 70-105mm or equivalent
  3. The date created should time stamp within 90 days of submission

TIP: view all three of your images together in compare mode to make sure exposures are consistent throughout your evaluation. Please double check your images prior to submission to ensure that you've met all of these requirements. Good luck!

## Recertification

Every 3 Years, CPPs must recertify by submitting 15 Continuing Education Units (CEU's) or retaking the CPP Exam.

Please review the chart below to learn how to earn CEUs or where CEUs may fall under the CEU point structure.

Units Earned	Continuing Education Unit Options

4	<ul style="list-style-type: none"> <li>Any face-to-face professional photographic development program lasting 4 days</li> <li>Teaching or speaking any PPA affiliated seminar/workshop lasting 4 days</li> </ul>

0.25	<ul style="list-style-type: none"> <li>Any face-to-face professional photographic development program lasting 1 – 2.5 hrs</li> <li>Teaching or speaking any PPA affiliated seminar/workshop lasting 1 – 2.5 hrs</li> </ul>
0.25	<ul style="list-style-type: none"> <li>PPA or PPA affiliate online content - 1 hour of content = 0.25* (videos, webinars, Facebook Live)</li> </ul> <p>*Maximum of 10 CEUs may be submitted for online education</p>

### To Recertify:

Fill out and submit with payment the **CPP Recertification Form**. Recertification CEUs can be any professional development or industry-related education.

The \$100 recertification fee is waived if any of the following requirements are met:

- CPP has attended Imaging USA for the past three consecutive years
- CPP is an Elite or Elite Plus Member

### No CEUs?

You have the option of **retaking the CPP exam** if you have not accumulated the 15 CEUs required to recertify.
